

## Rules and Waiver for PG&J's Dog Park Bar

- 1) DOGS CANNOT READ so please read our park rules in their entirety.
- 2) Our dog park is 21+. Furry children only please.
- 3) No dogs under 4 months of age.
- 4) All dogs must be spayed or neutered. NO exceptions.
- 5) All dogs must be current on vaccinations Rabies, Distemper, Parvo, Bordetella and Canine Flu.
- 6) Three dogs maximum per person.
- 7) No outside human drinks, dog food, treats, toys, or chews allowed.
- 8) All dogs must be in good health with no injuries, wounds or parasites.
- 9) All dogs must be friendly and sociable.
- 10) All dogs in the park must wear a collar displaying current tags with name and contact info. All leashes, choke chains, prong collars, head collars, and harnesses must be removed in the transition area prior to entering the park.
- 11) All dogs must be registered on-line at [www.pgjdogbar.com](http://www.pgjdogbar.com) or on-site at PG&J's Dog Park Bar. Owners are responsible for their dog's behavior. Kindly pay attention. Keep your dog's leash with you at all times.
- 12) Respect your Bark Rangers. If asked to separate your dog, leash your dog, or remove your dog, kindly do so quickly. Ignoring a Bark Ranger's request may lead to removal from the park by PG&Js management.
- 13) Bark Rangers may separate dogs, redirect them to more suitable play, use water squirt bottles and other benign methods to deter rambunctious behavior, or physically remove them from the premises.
- 14) Dogs known to be aggressive are not allowed in the park.
- 15) No foster dogs allowed without written consent from the foster organization.
- 16) Kindly clean up after your dog. Bags and receptacles are provided.
- 17) All dogs in the park must be accompanied by an owner/handler at all times. If you need to leave the park for any reason, take your dog with you on leash or ask a Bark Ranger for help.
- 18) Small dogs may enter the large dog area at the pet parent's discretion. Large dogs may not play in the small dog area unless given approval from a Bark Ranger.
- 19) YOU are responsible for your dog's behavior and the safety of you and your dog.
- 20) YOU knowingly and voluntarily assume any risk of harm to you and/or your dog.

## WAIVER OF LIABILITY AND COVID-19 WAIVER

**\*\*PLEASE READ CAREFULLY\*\***

- I understand that PG&J's Dog Bar, LLC is a social membership club that allows dogs to be off leash and otherwise be present at the applicable premises ("the Activities"). I understand that I am solely responsible for my wellbeing and safety, and the wellbeing and safety of my dog(s). Neither PG&J's Dog Bar, nor its employees, owners and/or staff are responsible for me or my dog. I attest that I have read the Park Rules and my signature below indicates that I understand and will abide by the Park Rules in their entirety.
- I am fully aware of the risks and hazards connected with the Activities and hereby elect voluntarily to participate in same knowing that said participation may be hazardous to me and/or my property. **I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING SICKNESS AND/OR DEATH, that may be sustained by me and which arises from my participation in the Activities.**
- I am fully aware that photos will be taken of the dog park, bar and it's human and canine customers. I consent that these photos may be used on PG&J's Dog Park Bar social media and website.
- I am fully aware that by signing this agreement I am considered a "Member" of PG&J's Dog Park Bar.

Further, I acknowledge the contagious nature of COVID-19 and that the CDC and many other public health authorities still recommend practicing social distancing and limiting exposure to others. I acknowledge that PG&J's Dog Bar cannot guarantee that I will not become infected with Covid-19 by my participation in the Activities or otherwise. I understand that the risk of becoming exposed to and/or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to P&GJ's Dog Bar staff and patrons. I voluntarily participate in the Activities and acknowledge that I am increasing my risk to exposure to COVID-19.

I attest that:

- \* I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- \* I have not traveled internationally within the last 14 days.
- \* I have not traveled to a highly impacted area within the United States of America in the last 14 days.
- \* I do not believe I have been exposed to someone with a suspected and/or confirmed case of COVID-19.
- \* I have not been diagnosed with Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- \* I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the PG&J's Dog Bar, LLC, and its officers, employees, contractors, servants and agents (collectively "RELEASEES") from

any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, sickness, or injury, including death, that may be sustained by me, or to any property, while I am participating in said Activities and/or as a result of exposure to COVID-19.

It is my expressed intent that this release and hold harmless agreement shall bind my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, and CONVENANT NOT TO SUE any of the RELEASEES.

In signing this release, I acknowledge and represent that I HAVE READ AND UNDERSTOOD THE FOREGOING LIABILITY WAIVER AND THAT I SIGN IT VOLUNTARILY as my own free act and deed; no oral representations, statements or inducements not contained herein have been made; and I EXECUTE THIS RELEASE FOR FULL, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY SAME.
